(example: Well fee-\$675; ½ is \$337.50)	
CHANGES to the previously approved plans <u>or</u> greater than 180 days after expiration.	
- Regular Fees Apply	

* An approval of plans and specifications can be reviewed for one year if an application for renewal is submitted within 180 days of expiration. A fee equal to one-half (1/2) of the flat fee or initial plan review fee is paid. The approval will effective for one year from the date of expiration. *Chapter 1 Regulation 4f*
